

## **GCA Club New Membership Rules and Regulations:**

- 1) GCA Club New Membership shall be of two categories:  
(A) Ordinary Membership and  
(B) Institutional Membership

Note - Limited availability in Ordinary membership in 7,00,000 category.

- 2) The facilities of the GCA Club shall be for use by Members, their spouse, dependent children (Not above 18 years of age) and unmarried daughter up to 25 years only)
- 3) Ordinary Membership is for Individuals, Institutional Membership is for Firms, Limited Companies, Corporates and Institutions.
- 4) Membership fees for both the categories will be determined from time by the GCA Club Management, Membership fees are not refundable.
- 5) Institutions shall be permitted to nominate in writing nominees as per terms of membership to enjoy facilities of GCA Club membership. The nominees can be changed on written intimation to the GCA Club and by surrendering the old membership card by the institution.
- 6) The Membership and all the entitlements thereunder shall always be conditional upon payment of the Annual Subscription Charges, Service Charges, Guest Charges and other fees or charges by the Member.
- 7) The Management reserves the right to terminate the membership in case of Member violating any of the Rules & Regulations of the Club.
- 8) Dues of the GCA Club House i.e. Annual Subscription or any other charges recoverable shall be paid by the members within 20 days of serving of bill. Any unpaid dues beyond 20 days, the club shall charge a penal interest @ 1.5% per month. If an Amount of unpaid dues with the penal interest exceeds to Rs. 25,000/-, the GCA Club management will block usage of all club facilities to the member till such times all dues along with penalty are paid.

Further In case the dues are not clear within 6 months, GCA Club management reserves right to terminate the membership and take due legal actions to recover the amount.

- 9) All the payment to the Club shall be in favor of **“Gujarat Cricket Association Club House”**.
- 10) All members will have to settle their bills directly on Cash/Cheque/Card basis with respective GCA Club during their visits.
- 11) A Member or his/her spouse may bring along with his/her guests to the Club premises and only those gentlemen and ladies who are received in general society and may be introduced as **“Guests”**.
- 12) The Introducing Member shall be responsible to ensure that his/her Guests strictly observe the Club Rules and Regulations and Bye-Laws and must not leave the Club Premises before his/her Guests.
- 13) Members shall strictly follow the applicable rules and regulations and bye-laws that are applicable to their Guests. The Management reserves the right to suspend and Member, who takes undue advantage of this privilege to the detriment of the Club.
- 14) Each Member shall be issued a Membership card depending upon the type of Membership applied for i.e. Ordinary Membership and Institutional Membership and the manner of payment of Membership fee opted by the Applicant which shall at all times remain the property of the Club and must be returned upon ending of termination/discontinuation/surrender of Membership.
- 15) The Membership card must be produced for inspection or verification at all times or on demand by the any official or employee or duly authorized agent of the GCA Club.
- 16) These rules & regulations are subject to modifications as and when found necessary by the management for the proper functioning of GCA Club.
- 17) Facilities of the affiliated GCA Club are made available to members subject to the rules and regulations of respective affiliated GCA Club.
- 18) I understand that this membership gives rights only to use the facilities of GCA Club, Ahmedabad and other affiliated with GCA Club Centers. It will not create any right or

obligations to the title and interest in the ownership or management of GCA Club centers, Ahmedabad.

- 19) I have read and understood all regulations of GCA Club, Ahmedabad. I further undertake to be abiding by the rules and regulations and bye-laws of GCA Club, Ahmedabad which are in force and as may be amended from time to time.
- 20) GCA Club management may accept or reject any application for membership without assigning any reason what so ever.
- 21) GCA Club management reserves right to decide the fees for all the facilities, amenities and services. Also reserves absolute right to provide any additional facilities at its sole discretion. Any facilities, amenities, services rendered by the Club to its Members as the case may vary Annual Maintenance Charges or such other fees and or charges levied in the Members for using, availing of the Facilities, amenities, services at the Club House without any prior notice or intimation to the members and that the decision of the Management in such matters shall be final and binding upon all the Members of the Club.
- 22) I will observe proper decorum and dignity. I will not cause any harm, inconvenience to the members, guests, management staff or property of GCA Club and will not indulge in any activities which are against the law and for any such misconduct or misbehavior. I understand that my GCA Club membership will be cancelled immediately given by the management.
- 23) I solely affirm that the information given by me in this form is true and correct.
- 24) Right of admission is reserve with the GCA Club Management.
- 25) Smoking is prohibited in GCA Club premises.
